Due to the number of "copycat" sellers that are appearing on 3rd Party Marketplaces, and particularly because some of them have the nerve to attempt to represent themselves as selling Driven Diesel or Strictly Diesel products (fakes), we have been forced to take steps to protect our brands.

In order to be authorized to sell Driven Diesel or Strictly Diesel products via a 3rd Party Marketplace, it is **REQUIRED** that we know which marketplace(s) you are utilizing, and what your seller name(s) are on each marketplace. The **ONLY** marketplace sellers that are authorized to sell Driven Diesel or Strictly Diesel products are those that have submitted this form, and received an "Approved" and "Signed" copy. Submitting the form is not enough, you are not authorized until we return the form with our approval and signature.

There will be no warranty on any Driven Diesel or Strictly Diesel product that is sold by an unauthorized 3rd Party Marketplace Seller Account...**NO EXCEPTIONS!** This includes sellers that are part of our regular "Jobber Level Dealer" or "Authorized Dealer" program, as well as sellers that have been authorized for one seller account, but then sold the product under another (someone with multiple "seller" accounts on the same platform). If we are not aware of the account, and we have not approved the account, the sale of ANY Driven Diesel or Strictly Diesel product will be considered "unauthorized" and the warranty will be void.

In case it isn't clear, we are extremely serious about this issue, violations will not be taken lightly!
